

NOTICE OF PUBLIC HEARINGS

TULARE COUNTY LOCAL AGENCY FORMATION COMMISSION

NOTICE IS HEREBY GIVEN that a Hearing will be held by the Local Agency Formation Commission (LAFCO) Tulare County. Hearings will be held at the ADMINISTRATIVE BUILDING, SUPERVISORS CHAMBERS, COUNTY CIVIC CENTER, 2800 W. BURREL AVENUE, VISALIA, on **Wednesday April 6, 2016 at 2 p.m.**, to hear and receive any oral or written protests, objections, or evidence which are made, presented, or filed regarding the following proposals:

- **Request for Reconsideration of LAFCO Resolution 16-003, Case# 1522b Deer Creek Storm Water District Annexation-** The Tulare County LAFCO approved the annexation on January 20, 2016. The terms and conditions for this annexation are set forth in LAFCO Resolution No.16-003, available for review at the address listed below. Two written request were filed requesting amendments to the approved annexation. The annexation includes 5 areas of nearly 36,000 acres roughly bounded by Kern County to the south, Kings County to the west, Road 128 (the westerly boundary of the Delano-Earlimart Irrigation District) to the east and Avenues 56 and 120 to the north. A map of exact boundaries can be obtained at the below mentioned address. At the conclusion of its reconsideration, the Commission may approve with or without amendment, wholly, partially, or conditionally, or disapprove the request. The determinations of the Commission shall be final and conclusive. No person or agency shall make any further request for the same change or a substantially similar change, as determined by the Commission.
- **Pre-Budget Fiscal Year 2016-2017 Budget and Work Plan-**Review and consider adoption of the preliminary budget for the fiscal year 2016/17 in accordance with Section 56381 of the Government Code of the State of California.
- **Sphere of Influence (SOI) Update for the City of Exeter-** This amendment would remove 6 acres and add 81 acres to the SOI to make it coterminous with the City's Urban Development Boundary. The proposed SOI is within the scope of the EIRs prepared and certified for the Exeter General Plan and the Southwest Exeter Specific Plan. Interested persons may inspect or obtain copies of the environmental documentation at 210 N Church St, Suite B, Visalia, CA 93291.

At the meeting, the Commission will consider all oral and written testimony of any interested persons or affected agencies. If you challenge the actions of Tulare County LAFCO on the review in court, you may be limited to raising only those issues raised at the public hearing described in this notice, or in written correspondence delivered to the Tulare County LAFCO at, or prior to, the hearing.
