NOTICE IS HEREBY GIVEN that a Hearing will be held by the Tulare County Local Agency Formation Commission (LAFCO). Hearings will be held at the TULARE COUNTY HUMAN RESOURCES AND DEVELOPMENT OFFICE, 2500 W BURREL AVENUE, VISALIA, on **June 1**st, **2022**, at **2:00 P.M.**, to hear the following proposals:

- SPHERE OF INFLUENCE AMENDMENT, ANNEXATION TO THE CITY OF PORTERVILLE AND DETACHMENT FROM CSA #1, CASE 1559-P-322 AND 1559-P-323A. An application was filed with the Executive Officer of the Tulare County Local Agency Formation Commission for a Sphere of Influence amendment, annexation to the City of Porterville and detachment from County Service Area #1. The proposal area for the annexation is approximately 19.53 acres of land and the proposal area for the Sphere of Influence amendment is for approximately 375 acres of land. The annexation area is located south of Gibbons Avenue, north of the Scranton Avenue alignment and is bisected by E. Kessing Street. The Sphere of Influence amendment area includes the annexation area plus the land directly west extending to Indiana Street and the land directly east extending to S. Hillcrest Street. The City of Porterville has prepared a Mitigated Negative Declaration for use in this project. As a responsible agency the Mitigated Negative Declaration will be considered at the hearing.
- SPHERE OF INFLUENCE AMENDMENT, ANNEXATION TO THE CITY OF DINUBA AND DETACHMENT FROM KINGS RIVER CONSERVATION DISTRICT AND FROM CSA #1, CASE 1564-D-63 AND 1564-D-63A. An application was filed with the Executive Officer of the Tulare County Local Agency Formation Commission for a Sphere of Influence amendment, annexation to the City of Dinuba, and detachment from Kings River Conservation District from County Service Area #1. The proposal area for the annexation is approximately 77.29 acres of land and the proposal area for the Sphere of Influence amendment is for approximately 38.9 acres of land. Both areas are located southwest of the intersection of Alta Avenue and Kamm Avenue. Dinuba Unified School District has prepared an Environment Impact Report for use in this project. As a responsible agency the Environmental Impact Report will be considered at the hearing.

Copies of environmental documentation, detailed boundary information and other information regarding these cases may be inspected or obtained at the Tulare County Local Agency Formation Commission, 210 N Church Suite B, Visalia, CA. Pursuant to GC §56375.3, the Commission intends to waive protest proceedings. If you cannot attend the public hearing described in this notice, you may submit written comments prior to the hearing. The Commission may, as a result of the hearing, approve boundaries for the proposed changes of organization that differ from and/or include more or less territory than that described. If you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Tulare County Local Agency Formation Commission at or prior to the public hearing.
