Pursuant to GC §56663(c), unless written opposition is received regarding this annexation the Commission intends to waive protest proceedings. If you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Tulare County Local Agency Formation Commission at or prior to the public hearing.
