NOTICE IS HEREBY GIVEN that a Hearing will be held by the Tulare County Local Agency Formation Commission (LAFCO). Hearings will be held at the ADMINISTRATIVE BUILDING, SUPERVISORS CHAMBERS, COUNTY CIVIC CENTER, 2800 W BURREL AVENUE, VISALIA, on **June 14th, 2017 at 2:00 P.M.**, to hear the following proposals:

- **DETACHMENT FROM THE ALPAUGH IRRIGATION DISTRICT (AID) AND ALPAUGH COMMUNITY SERVICES DISTRICT (ACSD) CASE 1531 (AID/ACSD).**
An application was filed with the Executive Officer of the Tulare County Local Agency Formation Commission for a detachment from the Alpaugh Irrigation District and Alpaugh Community Services District. The detachment from the AID consists of multiple parcels containing 841 acres of land located near the northwest, southwest and southeast boundaries of the district. The detachment from the ACSD consists of multiple parcels containing 117 acres of land located near the western boundaries of the district. Under CEQA sections 15320 and 15061 (b)(3) the proposal is considered exempt from CEQA review.
- **ADOPTION OF A FINAL BUDGET FOR FISCAL YEAR 2017/18.** The commission will consider the adoption of a final budget for fiscal year 2017/18 in accordance with Section 56381 of the Government Code of the State of California.
- **SPHERE OF INFLUENCE UPDATE FOR THE CITY OF TULARE, CASE 1511**
The Commission will consider the proposed Sphere of Influence (SOI) update for the City of Tulare. The City of Tulare is located within Tulare County approximately 10 miles south of Visalia. This SOI amendment is within the scope of the Final Environmental Impact Report prepared and certified for the SCH # 2012071064. LAFCO, as the Lead Agency, will review and consider the EIR prepared by the City of Tulare.

Copies of environmental documentation, detailed boundary information and other information regarding these cases may be inspected or obtained at the Tulare County Local Agency Formation Commission, 210 N Church Suite B, Visalia, CA. Pursuant to GC §56663, unless written opposition is received regarding the changes of organization the Commission intends to waive protest proceedings. If you cannot attend the public hearing described in this notice, you may submit written comments prior to the hearing. The Commission may, as a result of the hearing, approve boundaries for the proposed changes of organization that differ from and/or include more or less territory than that described. If you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Tulare County Local Agency Formation Commission at or prior to the public hearing.
