# V. Continued Action Items

1. Adoption of the City of Dinuba Municipal Service Review (Pages 4-23)

Public Hearing]......Recommended Action: Approval

Tulare County LAFCO will consider the adoption of the City of Dinuba Municipal Service Review update. The MSR and its determinations were distributed to the Commission and posted for public review on March 14<sup>th</sup>. At the April 2012 LAFCO meeting the County of Tulare requested a 60-day continuance to allow the opportunity for the Dinuba City Counsel and the Board of Supervisors to consider a proposed amendment to the existing memorandum of understanding. This item is exempt from the California Environmental Quality Act: Section 15061(b)(3).

# 2. <u>Initiate Sphere of Influence Update to City of Dinuba, (Pages 24-25)</u> [No Public Hearing] .......Recommended Action: Initiate

With the adoption of the MSR it is recommended that the Commission initiate a Sphere of Influence Update for the City of Dinuba. The SOI Update is currently planned to be brought back to the Commission for action at the July 11<sup>th</sup>, meeting.

The Commission decided to apply \$50,000 to offset the contribution from the County's eight cities and Tulare County. All expenditures and revenues are itemized on a single spreadsheet and the work program provides further detail on how these expenditures and revenues will be allotted during the fiscal year.
