****** NOTICE OF PUBLIC HEARING******

NOTICE IS HEREBY GIVEN that a Hearing will be held by the Tulare County Local Agency Formation Commission (LAFCO). Hearings will be held at the ADMINISTRATIVE BUILDING, SUPERVISORS CHAMBERS, COUNTY CIVIC CENTER, 2800 W BURREL AVENUE, VISALIA, on **April 7th, 2021 at 2:00 P.M.**, to hear the following proposals:

- **ANNEXATION TO THE CITY OF DINUBA, DETACHMENT FROM CSA #1 AND DETACHMENT FROM KINGS RIVER CONSERVATION DISTRICT, CASE 1555-D-62.** An application was filed with the Executive Officer of the Tulare County Local Agency Formation Commission for an annexation to the City of Dinuba, detachment from County Service Area #1 and detachment from Kings River Conservation District. The proposal area is for approximately 7.28 acres of land located northwest of the intersection of El Monte Way and Randle Ave. The City of Dinuba has prepared a Negative Declaration for use in this project. As a Responsible Agency the Negative Declaration will be considered at the hearing.
- **DETACHMENT FROM PORTERVILLE IRRIGATION DISTRICT, CASE 1556 (PID).** An application was filed with the Executive Officer of the Tulare County Local Agency Formation Commission for a detachment from the Porterville Irrigation District. The proposal area is for approximately 15.2 acres of land located at 19628 Ave 144. Tulare County LAFCO has prepared a Notice of Exemption for this project.
- **ANNEXATION TO THE CITY OF VISALIA AND DETACHMENT FROM CSA #1, CASE 1557-V-454.** An application was filed with the Executive Officer of the Tulare County Local Agency Formation Commission for an annexation to the City of Visalia and detachment from County Service Area #1. The proposal area is for approximately 19.61 acres of land located approximately 300 feet northeast of the intersection of Akers St and Sedona Ave. The City of Visalia has prepared a Negative Declaration for use in this project. As a Responsible Agency the Negative Declaration will be considered at the hearing.

Copies of environmental documentation, detailed boundary information and other information regarding these cases may be inspected or obtained at the Tulare County Local Agency Formation Commission, 210 N Church Suite B, Visalia, CA. Pursuant to GC §56375.3, the Commission intends to waive protest proceedings. If you cannot attend the public hearing described in this notice, you may submit written comments prior to the hearing. The Commission may, as a result of the hearing, approve boundaries for the proposed changes of organization that differ from and/or include more or less territory than that described. If you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Tulare County Local Agency Formation Commission at or prior to the public hearing.
